



GTL Collect & Send™ Today DNA Test Instructions

In order to collect DNA samples successfully, it is important that you follow the instructions below. Please read the entire instructions sheet before beginning and collect only one applicant's DNA sample at a time.

1. Do not drink tea or coffee, or use tobacco products for 4 hours prior to sampling. **Samples containing tea, coffee or tobacco residues may not process properly**
2. Gather the following items together before starting the sampling process. Do not touch swab tips with your fingers.
 - o 2 sterile cotton-tipped swabs for each participant to be tested (these can be purchased at most chemists or pharmacies). Cotton buds can be used but are not recommended. If you do decide to use cotton buds, cut off one end so only one cotton-tipped end remains
 - o 1 paper envelope per applicant to be tested
 - o 1 envelope measuring 6" x 9" (15 x 23cm) or larger
 - o Warm water for adults and children, room-temperature water in a baby bottle for infants
3. Wash your hands thoroughly and rinse each applicant's mouth three times with **warm water**. Do not use toothpaste or mouthwash. (For infants – wait 2 hours from last feeding and allow them to drink water at room temperature from a bottle)
4. Label the paper envelopes for each test participant with the individual's name, ethnic group and relationship to the rest of the group (eg. Alleged father, mother, child). *(See page 3 for an example of how to do this correctly).* Use one of the following only for the ethnic group:
 - o Caucasian (white)
 - o Black Caribbean
 - o White Caribbean
 - o African
 - o Asian
 - o Other
5. **DO NOT TOUCH THE TIP OF THE COTTON SWAB.** Collect cheek cells by rolling the tip of the sample collection swab firmly on the inside of the cheek (30 times or for about 1 minute). Be certain to move the swab over the entire inner cheek surface. This action should be firm but not aggressive and should not be uncomfortable
6. Repeat this process for the same individual with the second swab. **You must submit two swabs per person**
7. Allow the swabs to air dry at room temperature for at least 15 minutes. **To avoid contamination, do not allow the tips of the swabs to touch anything.** Place swabs in the envelope labelled with that person's name. Be sure to seal the envelope firmly
8. Repeat steps 3–5 of the sample collection process for each applicant
9. **IMPORTANT:** When you are finished, you should have 1 sealed envelope per person, each containing 2 swabs
10. Complete the registration form in the next section and post the sample collection envelopes, completed registration form and payment to GTL. We recommend that they are returned to us by Recorded or Special Delivery to:

As soon as we receive the DNA samples at our offices, they will be dispatched to our laboratory for testing. Your results will be available 5 working days after the samples are received by our laboratory. We appreciate the confidentiality with which these results must be provided to you and therefore can either post them upon receipt (sealed for the applicant's attention only) or e-mail them for the applicant's attention. Please indicate your preference on the Registration Form.

We offer a Rush Processing service, at extra cost, for clients who require a more immediate answer. Please contact one of our customer service advisors for more information. It is important that we are notified as soon as possible if you require Rush Processing as our laboratory must be made aware of this prior to receipt of the samples.

It is sincerely hoped that we are able to provide the answer you seek from these tests, however we would also urge you to consider the repercussions of an unfavourable response. 3. 'Sample', 'DNA sample' or 'Paternity sample' shall mean mouth swab or any other biological sample accepted by GTL for DNA analysis. 'DNA paternity testing' and 'DNA paternity analysis' shall refer to any type of relationship analysis and shall be carried out using whatever genetic test (or tests) deemed necessary by GTL.

4. All sales are final. If DNA test services are cancelled before shipping and/or handling a £19 refund processing fee will be deducted.

5. GTL will only conduct the requested DNA analysis on receipt of a completed GTL registration and order form accompanied by the correct fee for the service requested. In addition the samples received must be in the sealed sample envelopes countersigned by the applicant indicating that they have personally collected the samples and that these have not been contaminated. GTL reserves the right to withhold test results until cleared payment has been received.

6. In the event that GTL initiates legal action or appoints an agent to recover unpaid testing fees we reserve the right to add reasonable collection expenses and legal costs to the outstanding debt. Stopped payments will incur a £25 administration fee when represented.

7. The test report is provided solely for the information of the applicant and is not deemed admissible as evidence in a court of law. If it is intended that the tests are to be used in any court proceedings you should obtain independent legal advice before seeking a DNA test and ensure that GTL are informed prior to commissioning the test.

8. The applicant confirms that they are legally entitled to possession of the samples supplied to GTL. The applicant accepts to cover GTL for any loss or damage that we may suffer as a result of the samples not having been obtained legally. Applicants should, if in any doubt, seek independent legal advice about their entitlement to obtain samples before doing so.

13. GTL will take all reasonable steps to ensure that reports are provided within the advertised time frames but cannot accept any responsibility for delay caused by a third party or parties.

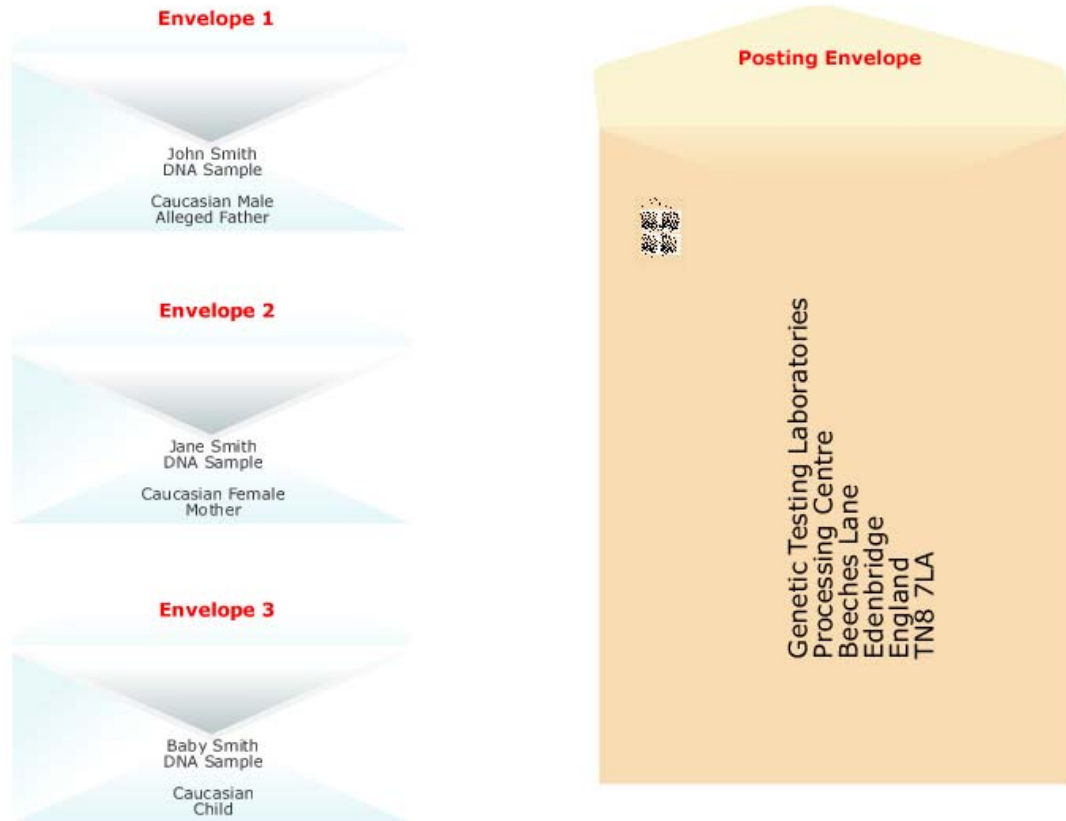
